



## PSEGLI OSPREY "FIRST HATCHED" CONTEST OFFICIAL RULES

**Eligibility.** Subject to the additional restrictions below, the **PSEGLI OSPREY "FIRST HATCHED" CONTEST** (the "Contest") is open to students participating in PSEG Long Island's I AM Empowered video contest. Children of employees, independent contractors, and any other persons or companies who receive compensation from PSEG Long Island LLC ("Sponsor" or "PSEGLI") or the Long Island Power Authority are not eligible to participate in this Contest.

**How to Enter:** The Contest Entry Period will begin on April 20 2021 at 9:00 A.M. (E.T) and end at 6:00 p.m. (E.T) on June 10, 2021 or when an osprey egg is hatched in one of the osprey nests described below, whichever occurs first with respect to each nest. Students will guess the date when the first egg will hatch in one or both of two Osprey Nests previously built by PSEG Long Island. The Osprey Nests feature live-cam feeds which can be seen at <https://www.psegliny.com/wildlife/ospreycam>. Students will record their 'First Hatched' prediction by completing an entry form/parental permission slip provided by their teacher. Students can only provide one submission for each nest location. Teachers will then report the predictions to [peter.hornick@pseg.com](mailto:peter.hornick@pseg.com). Sponsor will not be responsible for incomplete, lost, late, misdirected entries, or for failure to receive entries due to transmission failures or technical failures of any kind, including without limitation, malfunctioning of any network, hardware or software, whether originating with sender or sponsor.

**Winner Selection.** PSEGLI will select a winner for each nest location (Patchogue and Oyster Bay) based on the entry closest to the actual date when the egg(s) are hatched without exceeding the date the egg is hatched. An egg is considered hatched when the shell is broken and a portion of the chick is visible on camera, as confirmed by PSEGLI staff. If multiple entrants predict the same date, one entry will be drawn randomly from that pool of successful entries. If no eggs are hatched by June 10, 2021, a winner will be selected from a random drawing of all entries from that nest location. Winners will be selected for each location as soon as possible from the date the eggs are hatched, but no later than June 10, 2021.

### **Prizes**

**Student Winners:** Each student winner shall receive 4 tickets to the Long Island Aquarium with a cash value up to \$35.00 each (total tickets value up to \$140.00). Two winners in total will be selected; one for each PSEG Long Island nest location (Patchogue and Oyster Bay). Long Island Aquarium tickets awarded must be used by September 30, 2021.

Odds of winning depend on the number of eligible entries received.

**Winner Notification and Acceptance** When a winner is selected, PSEGLI will notify the student by contacting them using the information provided in the entry form. If the winner cannot be contacted or respond by this means within ten days, an alternate winner will be picked. Tickets will be sent by UPS to the address provided.

Prizes are subject to availability and Sponsor reserves the right to substitute prizes of equal or greater value. Winners are solely responsible for reporting and payment of any taxes on prizes. Failure to comply with any term or condition of these Official Rules may result in a winner's disqualification, the forfeiture of his or her interest in the prize, and the award of the prize to a substitute winner. Prizes (won by minors) will be awarded to a parent or legal guardian.. Except where prohibited, acceptance of any prize by a parent or guardian constitutes such parent's or guardian's consent to the publication of his or her child's name,

biographical information and likeness in any media (including the Internet) for any commercial or promotional purpose without further compensation and waiver and release of all claims that he or she may have against Sponsor arising directly or indirectly out of the Contest. Prizes not won and claimed by eligible winners in accordance with these Official Rules will not be awarded and will remain the property of Sponsor.

**Participation.** By participating, students and teachers agree to be bound by these Official Rules and the decisions of Sponsor. Sponsor reserves the right to disqualify persons found tampering with or otherwise abusing any aspect of this Contest as solely determined by Sponsor.

**Construction.** The invalidity or unenforceability of any provision of these Official Rules shall not affect the validity or enforceability of any other provision. In the event that any such provision is determined to be invalid or otherwise unenforceable, these rules shall be construed in accordance with their terms as if the invalid or unenforceable provision was not contained therein. Any disputes or complaints regarding this Contest will be governed by the laws of the State of New York without regard to its choice of laws provision.

**Sponsor.** The Contest is sponsored by PSEG Long Island LLC. The decisions of Sponsor regarding the selection of winners and all other aspects of the Contest shall be final and binding in all respects. Sponsor will not be responsible for typographical, printing or other inadvertent errors in these Official Rules or in other materials relating to the Contest.
